Abstract: One of the biggest manufacturers in Bridgeport, the Warner Corset Company - later the

Warner Brothers Company, then Warnaco - was a major part of the city's industrial

history. Starting with Dr. Warner's Health Corsets the company expanded, manufacturing corsets and then bras and other undergarments such as girdles, later branded as slimwear. The company left Bridgeport in the 1970s. It remained in existence until 2013, when it was bought out by PVH. This archival collection documents the early history of the company into the 1970s through family papers, corporate documents, daily operations, garment construction information, and extensive advertising material, all donated by Warnaco.

Administrative History

The history of the Warner Corset Company is lengthy, with several books published about its history.

Founded by Lucian and Ira DeVer Warner in 1874, the company was a reaction to the health issues that the two siblings, who were also doctors, saw in their female patients due to corset wear. They developed a more flexible corset, with the boning material coming from ixtle – a plant native to Mexico. Once treated, the fibers became material called Coraline which allowed greater freedom of movement and lightened the pressure put upon the wearer's body versus other boning material. Called Dr. Warner's Health Corset, the business took off immediately, with the brothers moving manufacture from McGraw, New York, to Bridgeport, Connecticut in 1876. Demand required that the Bridgeport business be scaled up to larger factories multiple times in the early years. Likewise, the firm also began to manufacture accessories to go along with the corsets themselves.

The health corset, also called the Coraline corset, was later phased out by the company's development of rust proof steel boning, which began in 1894 - the same year that D.H. Warner (son of I. DeVer Warner) took over the company. This development, later the standard boning for all corsets, was a major coup in production design and development for the company, and the

advertising bears this out as well. As the 1900s began, the trend for extremely tight lacing was in vogue, meaning that the company was in the black and able to develop even more styles. This went on to include corsets that went down to and past the hip. Also at this time, the bra was being developed, and Warner was a part of that development as well.

Changing styles did see the company deal with particular challenges, especially with regards to 1920s fashion when flat chests were in vogue. While some products were developed, such as fashionable girdles, sometimes called "wraparounds," the company mostly worked on developing and distributing in Europe, Mexico, and other regions. It wasn't until the Great Depression that real trouble set in, as customer spending dropped off sharply.

It was, however, the 1930s that saw the development of elastic thread, called Lastex, which marked a major change in the production of undergarments. It allowed for more wear and tear of a garment, and with that came new marketing which proudly promoted the new material, its lightness, and its longevity.

The 1930s also saw the development of the Warner's longest lasting contribution to the undergarment industry: the creation of cup sizing for bras which is still in use today. This was first developed in 1935 with A, B, C and D cups and has remained in use ever since.

During the 1940s, the bra truly replaced the corset as the women's support garment of choice, and the company continued production. Post-war production meant high demand, and the company tried to keep up - especially with finding enough people to work. This meant the expansion of production plants all over the US. This expansion continued into the 1950s, especially with the creation of the Merry Widow line of garments. Meant to work with the in-vogue high waist fashions, the Merry Widow was a cinch, half bra, and garter belt - and promoted with the Lana Turner film of the same name.

Merry Widow was a massive success and one that endured. At the same time, the Warner Company was also developing something even more enduring: the creation of lycra (a collaboration with DuPont), still a common fabric today.

Also during this time, Warner began to acquire other companies and continued to grow into the 1960s. Slimwear was produced with the creation of lycra, and still business boomed. The company changed its name to Warnaco in 1968, and continued to do excellent business. It left Bridgeport in the 1970s, which is when Warner donated the collection to the Bridgeport History Center.

The mid 70s to 00s focused on conglomeration and licensing agreements for production of garments outside of the Warnaco brand itself, such as Speedo and Calvin Klein. Financially however, the company began to sag in the late 1990s, and bankruptcy was declared in 2001. This did not last for terribly long, as by 2003 Warnaco was back - although not with the full set of licensing agreements that it once had.

Warnaco was bought by PVH Corp (Phillips-Van Heusen Corporation) in 2013. Under the PVH banner, the Warners brand of undergarments for women continues to sell, but it is the only remaining element of the company.

Scope and Content Note

Processing the material in 2019 revealed a greater depth of the collection's scope and contents. Personal material from the Warner family primarily revolves around D.H. Warner, rather than company founders Ira and Lucien. While useful for understanding the 1900s-1930s era of the company's founding family, those seeking exact information about Ira and Lucien will be disappointed.

Well represented, however, are the financial aspects of the Warner Brothers Company. Included are not only federal, state, and local taxes, but annual reports, employee payroll, and manufacturing information. These run from the 1920s to the 1970s, just before the collection was donated to the Bridgeport History Center. The ledger series also compliments this information.

Of course, the interest in Warner's often relates to their role in the development of the lingerie industry, starting with their 19th century corsets and moving into the 1970s. Early corsets are documented through the corset patent books, and the series that follows it, style books, provides manufacturing information about garments from the 1930s to the 1950s. This includes fabric, pattern numbers, and illustrations.

Advertisements make up the bulk of the collection, with material from the 1950s and 1960s representing about half of the boxes. It is a highly visual collection, with some memos and internal documents attached to proofs, garment designs, and other such pieces. It is unclear what the original order of the advertisements was, or if there was any at all, and so the arrangement of material had to be standardized according to decade. However, each decade consistently includes drawn sketches of garments (especially through the 1920s), photographs, and layouts for print advertising. Some decades include storyboards for TV ads, and pricelists that include the year's (or season's) garment lineup. Only the 1960s material features clearly delineated spring/summer and fall/winter lines. Fashion historians with a focus on undergarments will find useful material in this section.

At the current moment, the Bridgeport History Center is unable to view the films that are a part of this collection, and as such, cannot comment on their content.

Arrangement Note

This collection was originally arranged in the 1990s, and processed according to standards at the time with a simple inventory generated. Reviewing the contents with an eye towards contemporary (c. 2010s) standards was in the cards for some time, with the goal of improving both physical and intellectual control.

Starting in 2018, the first major group of records was reviewed and re-processed, building off of the original inventory. That inventory had no defined series, only approximate groupings of like material. The processing archivist first conducted an audit of the boxes, creating a folder level list for all initial 68 boxes. From there, series were created, and arrangement began in earnest, and starting towards the end of 2018 and continuing for most of 2019. Advertisements followed, which proved to be the most intense and lengthy phase of processing due to volume and low levels of intellectual control. Scrapbooks, films, and ledgers followed, although the condition of the ledgers dictates that access to them is presently restricted.

Series I, The personal papers of the Warner family combines information about personal and business life of the Warner family. Unfortunately there is minimal material from Ira DeVer Warner,

one of the founders of the Warner Brothers Company. What material does relate to him has been placed first.

The bulk of the material is from DeVer H. Warner and his wife Maude. D.H. Warner took control of the company after Ira, and within the series is extensive correspondence and expenses information. The same is also true for his wife Maude. Their material has been placed after Ira's due to both volume and D.H.'s importance in company history. Please be aware that D.H.'s correspondence is mostly personal, but may contain reference to business.

Eva, Ira F. and B.G. Warner were all trustees of D.H. Warner (meaning he controlled their finances). Their presence in the collection demonstrates how the family's wealth was managed and what was being bought at the time.

The estate papers at the near end of the series are small in volume and date from roughly the 1930s onward, and thus have been placed near the end of series I.

Material relating to the Warner Realty Company would normally be placed at the end of the entire collection, as it has nothing to do with the Warner Corset Company and instead represents another business venture of the Warners'. However, it was decided that this small volume of documentation would be placed at the end of series I instead because of processing rates and a desire to ensure that the material was accounted for.

Series II, Business activities of D.H. Warner, features account books that were originally mixed in with D.H. Warner's personal account books. They have been placed in their own series owing to the fact that it is likely researchers will wish to look at his specific notes. Additional ledgers may be found in ledgers series. It is unclear why some of these account books were placed with family papers when they were first reviewed and an inventory was generated versus left with other ledgers.

Series III, Annual and quarterly reports, shows the overall corporate activity of the company over time. Arranged chronologically, these reports also show how the format of the reports and the information they contained evolves over time to meet the needs of the business.

Series IV, Other corporate activities groups together the minimal other corporate activity documents that did not form other series. Like documents are placed with each other, and then arranged chronologically. There is also a small group of material about one of Warner's subsidiary brands, the Hathaway Company.

Series V, Taxes, contain federal, state, and local taxes, along with specific forms and additional data. Their order is then chronological.

Series VI, Payroll and employee documentation features payroll information that focuses mostly on the 1940s. This includes actual payroll books, accounts and stubs, tax information, and labor union agreements. Also present is information on unemployment insurance, first at the federal then at the state level. Arranged by like format, then chronological.

Series VII, Additional financial documentation, provides space for other financial information that does not fall into other series. It is arranged chronologically. Boxes 59-61 features large ledgers and journals that are housed by size.

Series VIII, Property and machinery, documents information about Warner's factories and the machines used for product. It is chronologically arranged. Boxes 63-67 contain oversized reports of property appraisals. They too are arranged chronologically.

Series IX, Corset patent books, contains some of the most frequently consulted material within the collection. Arranged chronologically, these books contain the patents for Warner corsets as they were filed, and offer insight into the development of corsets at the end of the 19th century. These corset patent books are fragile, and access may be restricted.

Series X, Style books and manufacturing information features a combination of notebooks and binders that relate to the manufacturing of undergarments by Warner from 1912 into the 1950s. Originally all of these books were deemed "style books", based on the way that numbers were assigned to patterns or products, depending on the book. The items have been kept together as a series, but specifics have been used to differentiate the different types of information recorded.

Boxes 73-74 contain what the first inventory called "style books." These contain product overviews for each garment including color, fabric, and product number.

The next group, in boxes 75-76, contains product or pattern numbers, date of manufacture, date something was dropped from manufacture, and general production information. Information about garment construction, including sketches and pasted in images of various pieces, are also in box 76. The final part of the series is similar to the previously described notebooks, but relates to specific lines of information. In particular, the corselet is well represented.

Series XI, Fire department, contains documentation of the company's on-site fire department. It is arranged chronologically.

Series XII, Public relations, is a small series, with many other PR materials held in the Sales, Marketing, and Advertisements series (due to the fact such PR communication is attached to items.) Material related to executives and PR is placed first, followed by correspondence, then press and publicity releases.

Series XIII, **Photographs**, features photographs of buildings and grounds, personnel, and corporate activities. These include the so-called "corset school" which instructed salespeople in how to sell and size corsets, and later the Warner's Training School from the 1940s to 1950s which served much the same purpose - and featured all women classes. Also included are photographs of fashion shows, which combine corporate activity and marketing.

Series XIV, Sales, Marketing, and Advertisements is the largest series, with subseries for the decades of the 1890s-1970s. Due to extreme volume, the folder listings for certain parts of the subseries may be general. Most material is not processed on an item level. There is some overlap with the clippings and scrapbook series.

Save for the 1890s-1910s, which are grouped together due to a small volume of material, each decade has its own sub-series. These sub-series generally contain four general groups of materials: marketing documentation and ephemera, original advertisement photography, and layouts. Layouts are typically lettering elements, in-progress advertisement layouts, and proofs for typesetting and for the final advertisement. This arrangement roughly resembles the assembly process for creating the ads, beginning with original sketch ideas and ending with completed works.

The marketing documentation and ephemera are placed first at the start of each sub-series in order to both provide researchers overview of how material was approached for that decade, and to keep small items in appropriately sized manuscript boxes rather than mixed in with oversized material. In one or two instances, other corporate activity which was filed in with the advertisements, is included in this section as well. Whenever possible, original art and advertisement photography has also been placed into manuscript boxes, following the marketing documentation and ephemera.

Beginning in the 1930s onward, there has been an effort made to isolate specific lines of major garments, such as the Le Gant in the 1930s and the original A'lure alphabet size bras (the first to use cup sizes) also in the 1930s, the Merry Widow in the 1950s, and so on. This has been done in order to ease the job of researchers who are looking for a specific product line, and for archivists who must respond to reference questions for information on particular garments. Product lines are placed first, followed by more general original art and advertisement photography groupings.

Due to storage concerns, no oversize box is larger than 20 by 24 inches. Larger material has been placed into oversized drawers.

Specific notes for the sub-series are as follows.

Sub-series A, 1890s-1910s:The first box in the series is-a manuscript sized box, and has been placed into chronological order, with original art and photographs placed at the end. Oversize material has been placed in the box after it, also in chronological order. Additional advertisements in the form of clippings can be viewed in the clippings and scrapbook series. Material located in the oversize drawer represents extremely large pieces.

Sub-series B, 1920s: This sub-series includes price lists and other ephemeral marketing material. The group of advertisement photographs represents various photos that were taken for use in ads in the form of a photoshoot, although they may or may not have been used. The second box of oversize material is entirely chronological, and contains several items that are labeled as "stand-up photo ad." These items are images mounted on cardboard and given little cardboard feet in the back to help prop them up. Such things would be placed on store shelves to help advertise the product.

Sub-series C. 1930s:

The 1930s is dominated by advertisement photographs for the highly successful LeGant garment, an extremely popular and well selling form of shapewear for Warner's. Less present, but highly important for the company, is the presence of material that relates to the introduction of the A'lure alphabet bra - the first bra to feature the now standard practice of alphabetical cup sizing.

There is some material presence about price lists and the soon out of fashion Redfern corsets that ended product in the 1930s

Sub-series D, 1940s

The first box in this series contains material that was already grouped by product type, such as bras and girdles, covering the late 1940s. The second box contains small advertisement photographs. Of particular note in this sub-series is the art for the spring and fall lines from 1948 to 1949, featuring a stylistic choice that sees the use of blue watercolor for shading. The rest of the material has been grouped by genre.

Sub-series E, 1950s

To begin, the 1950s features two boxes of original rolodex cards that list the names of stores that sold Warner garments. The cards only cover Oklahoma through Wyoming, and it is unclear if any additional cards existed in the collection. It is followed by three folders that represent an original binder of photographic materials, meant to serve as internal reference for the advertising department. Of particular note is a swatch book of sample garment material.

The 1950s features extensive packaging design, both in regards to the steps of packaging design (layouts, photographs etc.) and samples of the final boxes themselves. Garment lines include the Thanks Bra, the Good News line which features the strapless bra, the A'lure bra (the original line that introduced cup sizes), and the Merry Widow.

Original art and photographs help to compliment the more specific packaging design material. In several cases, the work of one artist has been made clear based on style, and thus grouped together. Unfortunately the commercial artists have left no signature on their pieces.

Sub-series F, 1960s

The sub-series for the 1960s is by far and away the most complicated sub-series in the entire collection. This is due to volume, and how the material was initially processed. Many large pieces of art, layouts, etc., contain correspondence on thin paper that was originally attached to the large item in question, and thus cannot not be separated due to the principle of original order. However, this is complicated by the fact that many items from different lines, garment types, and aspects of development were placed in the same box in the 1990s, making it at times difficult to determine like material. It is entirely possible that material in original art or in lay outs has a finalized version within the more organized garment lines that come earlier in the sub-series.

The sub-series begins with marketing information, correspondence, and price lists, representing an overview of activity in the 1960s. Note that often times price list proofs are within various garment lines later in the sub-series. The price lists present here were already isolated by a previous archivist, and it is unclear if these price lists arrived in such a state or through earlier processing. Also in this part of the sub-series are sales presentations, both in the form of overhead transparencies *and* large posters (stored in oversized drawers.) These presentations, some of which relate to Warner's men's lines, are the only such documents in the collection.

This part of the sub-series is followed by the marketing and sales information related to *lycra*, which Warner's helped develop along with DuPont. It is the only existing documentation of the company's innovation with regards to new fabrics.

Specific garment lines follow the Lycra information. In the early 1960s, the Warner's garment lines had few new additions from the late 1950s. It is not until the mid- 1960s that there is an upswing of new garments. Likewise, much of the marketing for various garment collections (the typical spring/summer and fall/winter lines, along with special ones released at various points in the year) comes from that same time period. Additional promotional materials, mostly intended for sales people/wholesalers rather than the consumer, follow the garment collections and also cover the same time period.

Much of the original art, photography, and layouts contain explicit dates until about 1966. At that point, the exact dating falls off, and so best guesses about when material dates from have been made. These guesses are often based on the garment(s) being advertised and the styling of the model (when applicable). True uncertainties have been designated simply "c. 1960s."

Sub-series G, 1970s

The 1970s sub-series is smaller compared to the 1960s, but the arrangement holds some similarity. General marketing documents have been placed first, and they are followed by advertisement layouts and proofs for specific undergarments. Most of these advertisements come from 1973 and 1974. The garments are arranged alphabetically by name of the product.

There is little original art for the 1970s, reflecting a shift to using photography for advertisement. As such, the advertisement photographs follow, and are rounded out by more general layouts for advertisements as they appeared in print. There is also a set of commercial storyboard layouts, which are labeled TV slides" by Warner.

Series XV, Clippings and Scrapbooks

Due to the fact that many of the scrapbooks *contain* clippings, the scrapbooks and clippings have been paired together. Scrapbooks and clippings that have been assembled by a clear department have been placed first, with several scrapbooks from the sales force documenting the 1920s to the 1940s. Some of these scrapbooks contain correspondence.

Three large scrapbooks of publicity clippings follow.

The advertisement department scrapbooks represent the work of the advertising department to collect completed ads as they appeared in print. It is unclear if these scrapbooks were placed with the other advertisements in the previous series or stored with the other scrapbooks. Due to that uncertainty, they have been placed here. These pages were originally placed into $16 \times 20 \times 5$ inch invoice books whose pages were sewn into the binding. The paper of these invoice books is extremely brittle, and the pages were removed from their binding because the binding was in poor condition and contributing to the further deterioration of the material.

The rest of the clippings are general clippings, some advertisements, some newspaper articles, mostly a mix, covering from the 1870s to the 1960s. One manuscript box contains individual advertisement clippings that were arranged in the 1990s.

While most material is bound in actual scrapbooks, the material from 1907 to 1929, which are primarily pasted advertisements onto pages, are extremely fragile and on very brittle paper that is prone to shattering. It is likely that many of these clippings came from scrapbooks and are in some sort of original order. Due to various factors, including storage and recovery of shattered pieces, the items have been broken into small groups to maintain the potential original order, then placed onto acid free buffer board. The pages, once on buffer board, have been wrapped in acid free tissue paper and then placed into boxes. It is expected that this will be a temporary measure and that appropriately sized folders will be used one day. Researchers must consult the archivist to be granted access to these clippings.

The very last box in the series has 30 folders of loose scrapbook pages, but it is unclear if they were all from the same scrapbook, from different scrapbooks, or how they came to be or be arranged. If there was information from this when the material was processed in the 1990s, it is currently unavailable.

Series XVI, Audio Visual Material

The material present in this series is documented at an item level and contains sound recordings and films, much of which is undated but likely from the 1950s-1960s. The Bridgeport History

Center does not have the playback equipment for the material, and thus cannot provide access at this time. Much of the film is from the 1950s, and includes information for sales people, commercials, and consumer information. Two films have been converted to DVD. Several of the films are currently missing.

Series XVII, Ledgers

Ledgers are documented at an item level, as they were not inventoried as a part of the 1990s processing. These ledgers vary from additional personal ledgers of the Warner family to cash books for daily operations to specialized ledgers for construction projects. They also include additional payroll information, tax information, and a large general selection of financial information as well.

The ledgers have not been incorporated into the initial corporate records, but instead are sectioned off into their own series. It was unclear to the archivists working in 2019 if the ledgers were included as a part of the initial Warner accession in the 1970s, or if they were transferred at some later date to the Bridgeport History Center. Likewise, it is probable that these ledgers were stored in separate areas away from other documents present in this collection. In an attempt to acknowledge these uncertainties, the ledgers have been placed into their own series. Their arrangement mirrors the structure of series I as close as possible.

There are ledgers that do not identify what corporate activities they document nor do they make it clear if there is a specific department it relates to, whereas there are others that do. These unclear ledgers have been marked as "general."

When possible, ledgers that clearly relate to each other (determined by similar markings on the cover of spine) have been kept together. Ledgers are roughly grouped together by decade with any specified ledgers (accounts payable, cashbook, etc.) placed first and the more general ones following.

Many of the ledgers are in poor condition due to red rot and quite a few are over 20 by 24 inches. Researchers wishing to use the ledgers are encouraged to contact the Bridgeport History Center staff, as there may be restrictions placed on volumes due to their condition. Likewise, the ledgers that relate to Social Security withholdings are restricted out of privacy and identity theft concerns.

Series XVIII, Outliers

A very small amount of material in the collection defied placement in any of the other series in the collection. They are accounted for in this final series.

Provenance

Donation from Warnaco received in 1978.

Restrictions

Corset patent books must be requested in advance and require an archivist to assist in retrieval. Audio/visual material cannot be played back at this time and is thus restricted.

Clippings, depending on which they are, may be subject to restriction due to their highly fragile nature.

The ledger series is entirely restricted, barring specific reasoning for access. This is particularly true for the social security information contained within those ledgers, due to concerns of identity fraud. This particular restriction is in place until 2119.
