## **Descriptive Summary**

Creator: Willis McDonald Title: Papers of Willis McDonald Dates: June 1863-April 1865 Quantity: ½ manuscript box Abstract: Willis McDonald served in Connecticut's 17<sup>th</sup> regiment during the American Civil War, and acted as the regimental historian. He recorded both his own accounts and that of other men in the regiment of major events such as Chancellorsville and Gettysburg. ### **Biographical History**

Willis McDonald was born in Brooklyn, 1842, the son of William McDonald and Mary Willis. He had two sisters, and was raised in a deeply religious Methodist Episcopal family. Around 1858, Willis moved to Norwalk, Connecticut, and began to pursue learning the carpenter trade.

McDonald enlisted in the Connecticut 17<sup>th</sup> regiment as a private in late August or early September of 1862. Remaining with the 17<sup>th</sup>, he saw some of the roughest fighting in the war, including that of Chancellorsville, Gettysburg, the Barlow March, Blocher's Knoll, and participated in siege operations at Morris Island, among others. Willis also acted as the regiment's historian and record keeping, meaning that much of the 17<sup>th</sup>'s experiences were recorded at his hand.

He left the army with the rank of sergeant. He married Mary E. Cole on April 1866, not long after he left the army in 1865. The two had three children together. McDonald's career after the Civil War's conclusion saw him enter the book printing business in New York City.

Wills McDonald died on February 27, 1919 in Amityville, New York and is buried at Pinelawn Memorial Park in East Farmingdale, New York.

Small in number and ranging in dates, this collection offers a small insight into McDonald's personal experiences of the Civil War.
