The papers of the Read family offer an intimate look at family photographs and manuscripts during the store's hey-day, with a particular focus on Muriel Read and her parents, Charles B. and Eleanor. ## **Biographical History**

#### The Reads

The Read family was an active family in Bridgeport's business and social communities in the midto-late 1800s. Their rise to prominence began with David M. Read,. He began by founding a dry goods company in 1857, which grew into the D.M. Read company in 1884. This company grew into a major department store in the city. David M. married Helen A. Barnum (a half-sister of P.T. Barnum), and the couple had three children: Charles B., David F. and May. They later played roles in expanding the Read businesses. David M. died in 1893.

Charles B. Read (-July 5, 1912) worked as a board member of the D.M. Read Company. He was born in the city of Bridgeport, and he wed Eleanor L. Atkinson in 1890. The Akinsons were of a similar social standing, and together the couple had a child named Muriel in 1904. Charles died a sudden death in July of 1912. A fire broke out at the Read estate, and two servants were trapped. He attempted a rescue, but he, along with Mr. and Mrs. Ruhl died in the fire. The sudden death of Read, along with the heroism of his rescue attempt, provoked mourning throughout the city, seeing stores shutterd and resolutions in his memory declared. Eleanor died many years later in 1948 at age 78.

Muriel A. Leeds nee Read (1906-1988) lead a very active life. She attended the Yale Fine Arts school, and married S. Gail Landon in 1928. It is unclear when she remarried, but with her second husband with Arthur she had one daughter, Ellen Read (July 19, 1939-). The family lived at the estate Restmore, originally owned by Dr. Ira DeVer Warner. Muriel died on May 25, 1988, in Southport, Connecticut, at the age of 82.

The Muriel Read Leeds and Ellen Leeds Sturges '53 Art and Horticulture Reference Library at the Unqowa School in Fairfield, CT was dedicated in Muriel's memory out of respect for the mother-daughter team's devotion to gardening and art education at the school.

#### D.M. Read Company

D.M. Read was began in 1857 as a dry good company, and then renamed D.M. Read Company in 1884. It became one of the premier places to shop in Bridgeport thanks to it's high quality goods. It boasted not only departments for typical clothing, hats, and the like, but included special rest rooms for shoppers as well. Business was exceedingly excellent into the 1920s, causing the store to move to a new building in 1926 at Broad and John Streets to support its business and offer even more amenities.

Read's fell under the jurisdiction of Allied Stores in 1954, and soon Read's became a chain. This was successful for a time, but in 1981, Read's flagship store at John and Broad closed down, moving it into a space at Lafayette Plaza Mall instead. Sadly, the name Reads was done away with in 1987 when another merger saw it change to the name of Jordan Marsh. That flagship building still stands, now the home of Artspace as of 2004, an area for artists to live and work. The ground floor features commercial space.

Bankruptcy by Allied Stores in 1991 saw the closing of most remaining stores, and more and more mergers saw an eventual takeover and being folded into Macy's. Read stores no longer exist.

# **Scope and Content Note**

Photographs make up the bulk of the collection, with an emphasis on Muriel A. Read as a baby and up until teenager-hood, and her mother Eleanor A. Read. Manuscript material is dominated by Muriel's correspondence with Frederick W. Blum, a British soldier serving in France in World War One.

Some earlier manuscript material does exist, having come from a bound red wallet. These items range from 1800 to 1840, and while not always signed, indicate the origin of D.M. Read's as a dry goods and then department store. Receipts belonging to Nathaniel Wheeler and his business dealings with Read's are also present.

A small amount of material relates to Read's department store itself, and includes interior photographs of the department store in the late 1880s/early 1890s.

#### Arrangement note

These papers are arranged with manuscript material placed first, then photographs, then secondary works, and it is rounded out by a small series related to the Read's family business. In the case of manuscript and photograph series, the most prolific creator was Muriel A. Read, and is thus given prominence. The accession also included multiple boxes of family silver and like items. Due to the extent of items and collecting policy, the Bridgeport History Center declined retention of the items.

#### Administrative information

Provenance: Donated to the Bridgeport History Center in 2017 from St. John's Church, where the Read family had worshipped for many years. The Reads left material to the church.
