# **Biographical Information or Administrative History**

Amzi L. Barber

Amzi Lorenzo Barber was born at Saxton's River in Vermont, 1843. His parents soon moved the family to Ohio, and Barber attended Oberlin College where he graduated from in 1867. For a while he flirted with post-graduate theological studies, but moved in the business world soon after. He began to make a headway in the business world by starting to pave roads with asphalt, which was a total novelty in the 1870s and into the 1880s. This company was christened the Barber Asphalt Paving Company in 1883.

This company went through several name changes, but the impact of paving did not go unnoticed major roadways were beginning to take shape at this time. In 1898, as automobiles were being experimented with, A.L. Barber founded the Locomobile Company of America, a luxury manufacturer that would endure it was sold to Durant Motors in the 1920s (see below.)

Barber's personal life saw him marry twice. His first wife, Cecelia Bradly, died in 1870 after two years of marriage. He soon remarried, this time to Julia Langdon. Julia was related to Mark Twain.

The couple had children, with 4 who survived to adulthood. His son LeDroit died in 1905. One daughter Bertha married Charles Vance, and his daughter Lorena married Samuel T. Davis Jr., the president of Locomobile. Their son Roland died when he was only 7. In Barber's spare time, he

was an avid yachtsman.

Barber died from pneumonia in 1909.

Samuel T. Davis Jr.

Samuel T. Davis was born in Washington, DC, on February 8, 1873. He attended Rensselaer Polytechnic Institute, and graduated in 1893 at the head of his class. A keen engineer, he began to focus his energies on the developing motor world.

This interest brought him into contact with Amzi L. Barber, who was a major player in asphalt and paving at the end of the 19<sup>th</sup> century. Davis married into Barber's family, wedding Lorena in 1897. Together, Lorena and Samuel had a daughter, Irene.

When Barber acquired Locomobile in 1899, Davis became the treasure, and later the president of the company in 1909. Davis' intense enthusiasm for early motorcars saw him actually create a world's record for driving a steam car over Coney Island Boulevard in 1900 (1 minute and 15 seconds for a mile.)

Davis died from complications of ptomaine poisoning, the final cause of death being cerebral hemorrhage. It is unclear how the poisoning occurred.

## **Scope and Content Note**

The Barber and Davis papers demonstrate close correspondence between both families, covering much of the time that Amzi L. Barber was Samuel T. Davis Jr's. father-in-law. In addition to the day-to-day workings of their various business ventures, personal correspondence is included. The dates cover the lifespan of the Locomobile Company of America until 1915 with Davis' death.

#### **Arrangement Note**

Material was found while cleaning back storage and originally thought to be a missed portion of the Records of the Locomobile Company of America (BHC-MSSS 0003.) Further examination proved that this was not the case, and *some* processing had been done, although not to current standards. One particular problem was the fact that the material written by Barber was mixed in with Davis (until 1909, the year Barber died), meaning that material from that time period needed to be parsed out. Some folders that proclaimed certain dates were incorrectly labeled, and at certain points "personal" papers had been separated out; likewise, 1912 was the only year to have correspondence parsed into months. Another correspondence series from 1903-1910 simply labeled Andsky-On-Hudson was separated out, and it is unclear if that was an original file label or not. Some correspondence subject files also existed.

As such, the archivist created the following series to deal with these problems: series 1 contains material related to A.L. Barber. Note that correspondence between Barber and Davis will likely also be in Davis' correspondence files.

Those correspondence files compromise series 2. Sub-series A contains correspondence to and from S.T. Davis Jr. arranged by year. Subseries B contains the so-called "personal" correspondence and the subject files. Note that 1916 onward relates to Davis' estate after his death.

Series 3 has the Andsky on Hudson papers. They are likely so-called due to number of correspondences addressed to that city.

The fourth series has paid bills from S.T. Davis, and series 5 is meant to catch all additional material included in the collection, including the will of A.L. Barber's wife Julia. The final series, series 6, contains canceled checks.

Material in this collection has been minimally processed. In the future it can undergo further refinement.
