Abstract: Originally built in 1807 by Abisha Woodward, the Black Rock Harbor Light, also known as Fayerweather Light, is one of the iconic buildings of Bridgeport. The records of the light which run from 1873 to 1933 give insight into day-to-day operations of the light from the tenure of

Stephen and Catherine Moore to the last official keeper, John D. Davis.

Administrative History:

The Black Rock Harbor Lighthouse, also called the Black Rock Harbor Light and Fayerweather Lighthouse, was originally built in 1807 with funding from the United States government. Abisha Woodward was responsible for construction, and the original building stood until a hurricane struck in September 1821. A new light was built and completed in 1823.

Operational until 1832, the light house had eight official keepers, and one caretaker who looked after the structure from 1933 to 1952. Most noteworthy of this group is Kathleen (sometimes given as Catherine) Moore, known as Kate. The daughter of keeper Stephen Moore, Kate began performing keeper duties at the age of 12 and continued until her own retirement in 1878. A full biography of Moore is <u>available here</u>. She is credited with saving an estimated 21 lives during her tenure.

The light house was decommissioned in 1932 and given to the City of Bridgeport in 1934, which in turn made the light house a part of Seaside Park. Unfortunately the building suffered for a time after that, with the interior sustaining damage and the keeper's quarters destroyed by a fire in 1977. Restoration efforts began in 1983, with subsequent efforts following in 1993 and 1998. The light house was relit in 2000, although it is no longer a functioning navigational aid as it once was.

The light house is not open to the public at this time.

Scope and Content note:

The bulk of the collection is made up of daily records of the light house, made by each subsequent keeper. It provides insight into the daily lives of both the keepers and Bridgeport's harbor for the last quarter of the 19^{th} century and first quarter of the 20^{th} . It also serves as a means of examining weather patterns over that same period of time. The accounts list the supplies and materials used

over the years, again giving insight into daily operations of a busy harbor.

Arrangement note: Daily records placed first, then arranged chronologically. Additional manuscript records follow, also arranged chronologically. Printed material has been placed last.
