Descriptive Summary

Abstract: The Contemporary Club was a Bridgeport social group meeting from 1894 until 2015. Unlike multi-chapter organizations, such as the Rotary Club or Kiwanis International, the Contemporary Club was independent and local, hosting lectures and musical performances several times per year. These collections reflect the Club's costs and member composition, as well as the planning and content of its gatherings.

Administrative History:

The Contemporary Club was founded in 1894 by Bridgeport elites – or, as its constitution stipulated, “distinguished men and women.” Its founder and first president, Thomas Cook Wordin, was descended from a family made wealthy by its drugstore emporium and management of real estate. Original membership featured the Hon. Morris Beach Beardsley, a judge with prominent roles in Democratic city and state politics; William Darius Bishop, inheritor and founder of several major railroad lines; and representatives of the Warner family, in charge of a profitable women's-underclothing factory.

Meetings, featuring musical performances or lectures, were held five or six times per year. After 1896, following two years of gathering in private homes, members typically assembled in the Brooklawn Country Club, located in the neighboring town of Fairfield, or in downtown Bridgeport's Algonquin Hotel.

The Club disbanded in 2015, donating its remaining money to the non-profit Bridgeport Public Education Fund.

Scope and Content note:

The well-preserved collection includes the Club's constitutions, minutes of officer meetings, yearly members' handbooks presenting officer lists and performance titles, and membership rolls joined by application and resignation/death dates. The Club's care in maintaining dues is on display in materials making up the Financial Records series. These records offer insight into cultural interests and social exclusion practiced by Bridgeport's affluent residents during the late 19th and early 20th century, along with how the Club evolved afterward as the city's economy and demographics changed.

Arrangement note:

Three series make up the collection: executive committee materials, membership mailings and name lists, and financial records. Index cards have been disbanded and rearranged to be flat in folders.

Administrative information

Provenance: Donated in part by Elizabeth Witsil, then the Club's secretary, in April 1959. In January 1980, Minnie L. Perry, also then acting as secretary, brought in a set of papers. Lynne Penczer contributed additional materials in July 2015.
