Abstract: Alyce Laurayne Farrar-James (June 9, 1926-May 6, 2019) was

heavily involved in the city of Bridgeport's social, economic, and political life. She worked as a local organizer for Dr. Martin Luther King Jr. in the state of Virginia, and took her experience back to Bridgeport where she helped transform the city by taking on such diverse roles such as City Council, Board of Directors for the Young Christian Women's Association, teaching within the Bridgeport school system and so much more. This collection represents a small portion of a remarkable legacy.

Biographical / Historical

Alyce Laurayne Farrar-James (June 9, 1926-May 6, 2019) was heavily involved in the city of Bridgeport's social, economic, and political life. The Farrar family itself has deep roots in the Little Liberia community, Bridgeport's safe haven for American and African born Black people escaping slavery in the south prior to the Civil War, as well as a place for the Indigenous residents of Connecticut to reside. Her mother, Alice Gertrude, was active and socially involved

as well, and in the past has been kind enough to share her life experiences through an oral history.

Alyce herself was a graduate of Howard University and the University of Bridgeport. She worked under the direction of Dr. Martin Luther King Jr. himself as a local coordinator while living in Richmond, Virginia - some of this experience is documented in the collection.

In continuing her work for social justice, inclusion, and fairer representation within the City of Bridgeport, Farrar-James worked in a number of roles within the city's government and within the community. These positions include City Council (for the East End of Bridgeport), a teacher within the Bridgeport school system, and sitting on the Board of Directors for the Young Christian Women's Association in Bridgeport. She worked to eliminate Mount Trashmore, engaged in civil rights lawsuits to ensure greater equity in the Bridgeport school system, and so much more. It is also worth noting that her family was always heavily involved in education in Bridgeport, and Alyce's elder sister, Geraldine Whiting Johnson, was the first African American woman to be superintendent of Bridgeport schools.

In her personal life, Farrar-James married Anthony F. James. Together they had three sons, and were part of a much larger extended family with many nieces, nephews, and grandchildren.

Scope and Contents

The bulk of the material within the collection relates to the most modern portion of Farrar-James' life, mostly from 2000 onward. There is a focus on personal spirituality and interests, but that is not the collection's exclusive domain. Series II and III can be best understood as snapshots of her interests and work in the 2000s, with an emphasis on education and local matters. The fifth series represents genealogy research on Farrar's family, but also work done to help Little Liberia and the Freeman houses gain recognition as a part of their restoration efforts. The folder labels, such as Auntie, center the personal nature of the research.

Arrangement

The papers of Farrar-James arrived with one box of office files in original order, and the rest of the material simply packaged together to make transport easier. Many folders had Farrar-James' labels, and those have been kept whenever possible.

This collection consists of five series. Series I, personal papers, is dominated by spiritual writing where she cites passages from the Bible and elaborates and contemplates them. These writings relate the passage to elements of her personal and work life, and run from about 2000-2019. There are two folders, placed at the very start of the collection, relating to her work in the Civil Rights movement.

Series II, office files, contains files from her office in original order. Series III, public office and working files relate to her various public positions in the City of Bridgeport such as that of the Board of the Education as well as organizations whose causes she championed.

Series IV, commendations and awards, hold paper and three-dimensional awards for her service.

The final series in the collection is series V, family papers, which includes extensive information about the Farrar family and the Little Liberia community,
