Abstract: The papers outline the Willards' experiences as leaders of union locals, primarily those of the United Electrical Workers of America (UE). Workplaces represented concentrate for the most part manufacturing plants in Bridgeport, predominantly General Electric and Columbia Records. The materials contain practical union documents, such as minute meetings, newsletters, contract agreements, and financial records, along with local and national texts reflecting the conflicts between the UE and the International Union of Electrical Workers (IUE). Also included are publications from nationally-based pro-union journals as well as papers distributed by GE and the National Labor Relations Board.

Biographical History:

Born in Naples, Italy, in 1915, Josephine "Jo" Willard (née Senese) immigrated with her family to Bridgeport in 1916. At the start of the 1930s, she worked at companies across the city: her father's hardware and bicycle shop; the Levine Coat Factory; Casco Products, where she helped manufacture cigarette lighters; Raybestos, a producer of brake linings; and the Electric Blanket Division of General Electric. She joined the Communist Party of the USA during her first decade of work, where she would play a critical role in organizing the International Ladies' Garment Workers' Union (ILGWU) at Levine. After transferring to GE after US entry into World War II, she served on the executive board of the plant local representing Electrical, Radio and Machine Workers of America (UE). In 1946, she ran – without success – for a position as a Connecticut state representative on behalf of the Communist Party of the USA. From the mid-1950s onward, she managed the office at Bridgeport Automatics and Compact Tools. She married Lloyd Willard, also a UE member, who over the 1950s and early 1960s served as president of the UE local representing workers at the city's Columbia Records plant.

Josephine Willard later took up the study of naturopathy, calling her own version of the practice "Natural Hygiene," and ran a call-in radio show bearing that title. In 1986 she collaborated in publishing a weight-loss book centered on its ideas, followed by a 1995 guidebook named *Blueprint for Health*. She died in 1999. Her husband, Lloyd, had passed 12 years earlier in 1987.

Scope and Content note:

The collection opens a window into mid-20th century Bridgeport industrial work and helps to illuminate leftist labor politics on a national level, as well as a local one. Communism in Bridgeport,

which was a manufacturing-based city, was a huge force – and one of the reasons that Mayor Jasper McLevy was the longest serving communist mayor in the country.

Many of the papers reflect battles between the UE and its more conservative rival, the International Union of Electric Workers (IUE). While there are few personal papers related to the Willards, records of their activities reflect discussions, theories, and strategies informing local and national unions' efforts to control labor power in the US. The broader entrenchment of anti-Communism and corporate anti-unionism underwrites many of collection's parent-union flyers and government-issued paperwork. Also relevant to these papers is gender's role within such divisions.

Arrangement note

Materials are divided into 4 series. Series I houses papers reflecting Josephine's life outside of her work for the UE local at GE. Its four documents range from around 1940 through 1960, comprised by a flyer urging rank-and-file participation in the upcoming national ILGWU conference, signed by Josephine, then secretary for Levine's local; a leaflet for her state representative campaign; Lloyd's draft account of a 1947 street attack aimed at Josephine, carried out by a veterans' council; and Josephine's 1960 script for a show analyzing US civil-rights struggles.

Series II shifts to an examination of UE activities at both GE and Columbia Records. Its newsletters explore the Columbia local's conflict with IUE efforts to oust it from the plant, while other UE-generated media focus on locals and districts outside of Bridgeport.

The third and fourth series cover national-level materials distributed by EU and IUE, and miscellaneous labor documents produced by companies, unions, federal boards, and pro-labor media.
