Abstract: Peter Spain served as a part of the Bridgeport City Council for a two year term, spured on by the sudden 29% increase in Bridgeport's mill rate/property tax rate. As a city councilor, Spain's

focus was primarily on health issues, education, economic development, and governmental

transparency. This is well represented in the collection, and there is particular weight to the matter

of the Water Pollution Control Authority and its aggressive approach to collecting payment.

Biographical History

The youngest of three children, Peter D. Spain was born in 1971 to John F. Spain (1939-2011) and Mary Mannion Spain (1941-). Peter attended public school in Bethel, Connecticut, graduated Phi Beta Kappa from the University of Virginia College of Arts and Sciences in 1993, and later earned a master's in chronic disease epidemiology from the Yale School of Public Health. In September of 2012, Spain and his spouse Kate Desmond Spain (1970-) move to the Black Rock area of Bridgeport from neighboring Fairfield.

Spain ran for office in 2016 to better represent the local community. This is due in no small part to the unanimous approval of the recent budget proposed by Major Ganim that forced a 29% increase in Bridgeport's mill rate/property tax rate.

Serving for one two-year term, Spain made an effort to publicly report his annual taxpayer funded stipend in order to encourage greater transparency from city officials. He also worked on health issues, education, economic development, and worked to engage constituents.

Scope and Content note:

The collection covers Spain's tenure as a councilman for the City of Bridgeport. This means a diverse array of topics are covered, from the city budget to matters related to the Board of Education to public health. As Spain served as a part of the Ordinance Committee, documents related to that process are present in large number.

In particular, there is a large amount of material within the Ordinance series that covers the Water Pollution Control Authority and its aggressive approach to collecting payment. This approach meant potential foreclosure for Bridgeport residents who were already in extremely vulnerable

positions. The Ordinance Committee, including Councilman Spain, worked with Bridgeport residents, retired Judge Carmen Lopez and Connecticut State Senator Marilyn Moore to try and address the issues at hands, which included liens on homes of elderly and disabled who'd failed to pay their sewer-use bills and/or to set up a payment plan resulting in foreclosures.

The efforts resulted in revised ordinances, making the collection process fairer by reducing the incentives of the outside lawyers to go for foreclosures and by increasing the power of the citizens in need to work with the city to establish a more manageable and timely payment plan.

Arrangement Note:

The collection is arranged into three series: subject files, ordinances, and city budget material. The arrangement of subject files reflects the original order that they were received in – alphabetical. Ordinances had some semblance of order imposed on them, with the first several folders in the series reflecting this fact. The rest of the ordinances did not, and so they were organized by topic. Material related to the WPCA take up the bulk of this series. Within the third series, related to city budget, the final published budgets (with Spain's annotations) are placed first and are followed by working materials and drafts.
