## Guide to the Digital Captures for Bridgeport Activist Organizations Collection

**Abstract:** Collection features interviews and digital media captured from the internet or digital files donated by three distinct activist organizations in Bridgeport: Justice for Jayson, an organization formed in response to a police shooting; Bridgeport Generation Now, a nonpartisan, grassroots social action network focused on civic action; and P.T. Partners, a group of residents of residents of the P.T. Barnum low income housing complex that organizes for self-determination and against racism and oppression.

### **Administrative History**

This collection is the result of a pilot project funded by the National Historical Publications and Records Commission (NHPRC) through the Connecticut State Historical Records Advisory Board (SHRAB) and State Library and administered by the Conservation Connection. The Bridgeport History Center created the collection as part of an ongoing initiative to acquire new collections which are more reflective of the city's diverse population and address gaps in the department's holdings while exploring new ways to collect and present digital content to researchers. The project was formulated and guided by archivist Brian Stevens of Western Connecticut State University (WCSU) who provided advice on applying current archival description standards and file naming conventions for the materials collected as well as information on and assistance with various tools and programs that can be used to harvest digital media. Stevens also uploaded the History Center's collection onto WCSU's OMEKA site and provided substantial instruction on loading and editing materials. (OMEKA is a web publishing platform for sharing digital collections and creating media-rich online exhibits.) The collection guide will be posted on the Connecticut Archives Online (CAO) site and some materials will eventually be available on the Connecticut Digital Archive (CTDA).

**Justice for Jayson** was founded in May of 2017 when fifteen year old Jayson Negron was shot and killed by a Bridgeport policeman after a short car chase leading to downtown Bridgeport. The incident immediately elicited a strong reaction from many communities in Bridgeport who have had negative interactions with the police and garnered a great deal of media attention. Jayson's sister, Jazmarie Melendez, friends, and family quickly organized the Justice for Jayson group, advocating for the firing of Bridgeport police officer James Boulay and reforms in the Bridgeport Police department. In the months after Jayson's death, the group demanded greater transparency from the Police Department, stating that video footage that captured the scene where Jayson died should be released to the public.

Justice for Jayson has established a major social media presence through its Facebook page which contains many interviews with group members and lists group events with related graphics. In the last three years, Justice for Jayson has organized protests against the Bridgeport Police Department, including a summer of 2020 camp-out with tents in front of police headquarters which lasted for several days, marches, anniversary memorials, and coordinated activities with groups concerned with police reform from across Connecticut. In early 2021, the group demanded public meetings on the selection of Bridgeport's next Police Chief. It continues to press for the firing of the officer who shot Jayson Negron.

The founders of Bridgeport Generation Now modeled their organization after Michael Segura's San Bernadino Generation Now, a group featured in a 2016 Atlantic Magazine article entitled "How America is Putting Itself Back Together" After a discussion with Segura, GenNow founder Callie Heilmann realized that Bridgeport shared many characteristics with the California city: "a post-industrial landscape" and "communities of color who are shut out of economic and political power."

The group's website states that "systemic corruption and systemic racism are directly tied to economic inequity in Bridgeport." By educating community members to use various tools of civic engagement, BptGenNow aims to break the cycle of "apathy, cynicism, helplessness, and disgust for collective civic life" and generate a sense of self-empowerment and self-determination in new generations of Bridgeporters who will assume leadership roles and build their own communities with their own vision for a better future. Generation Now aspires to practice "intersectionality, collective action, openness, ethics, and love" in pursuit of "good governance, justice and equity, and livability." It has garnered significant attention for its 2018 campaign to demand national standards in the selection process of the Bridgeport Police Chief. The organization has been holding monthly meetings since May of 2016.

Since 2014, **P.T. Partners** has organized around many issues that demonstrate intersectionality between race, poverty, education, and environment. The group has run school supply drives, organized a food bank for residents, day camps, and a clothes closet.

PTP's Anti-Oppression Task Force has investigated the PCC (Program Coordinating Committee -- usually consists of representatives of local government, employment and job training agencies, welfare agencies, nonprofit providers, local businesses, and assisted families) and HUD for what the group says are policies that have led to negligence in ensuring the safety and quality of life of residents and providing accurate and timely information on rental leases. The group continues to work with city and other officials on remediating the antiquated and dangerous sewage plant adjacent to the residents to reduce its impact on residents' health.

P.T. Partners has also spearheaded an effort to re-establish the Gary Crooks Memorial Community Center, a space that was once used by P.T. Barnum Apartment residents for a variety of social and educational, and civic activities that the Bridgeport Housing Authority (BHA) took over as office space.

As of this writing, PTP's Facebook page advertises the many events and initiatives that the group organizes throughout the year. As part of its mission, the group states that many of its programs are "a replicable model for transforming public housing neighborhoods into communities of opportunity."

### **Scope and Content Note:**

This is an artificial collection comprised of interviews conducted by the History Center with organization members, webpage captures, newspaper articles, and graphics and other images used by the three organizations for social media activity.

Newspaper articles about all three organizations have been printed as pdf's from online sites for local news publications.

Justice for Jayson donated many of the digital files for its portion of this collection, including interviews, and the order of these files as the group presented them has been maintained.

Graphics and other images were created by Justice for Jayson and come in both jpg and png format. They were generated for use on the group's extensive FaceBook page and for live demonstrations and events promoting the group's cause.

The History Center employed the HTTrack website capturing program to capture whole webpages and all of their subpages and components on a single date, each month, from November of 2020 to January of 2021. The resulting files reveal the content that Bridgeport Generation Now and P.T. Partners presented on their websites for this period. Tracking the sites over time provides insight to group activity and demonstrates changes and additions that the groups made to their sites.

Sample portions of the Bridgeport Generation Now and P.T. Partners websites from 2018-2020 are printed in pdf format. These are small snapshots of group activity and publicity as presented by the groups on their sites. Justice for Jayson does not maintain a website. None of the three organizations maintains a Twitter account.

The collection contains several interviews with members from all three organizations. Most of these are presented in the MP4 format for videos, but there is at least one audio only video presented in MP3 format in Series II.

The History Center set parameters to collect digital materials from all three organizations that date from 2017 to early 2021.

**Arrangement Note:**

This collection has been arranged into three series, one for each organization. Series I is comprised of material from Justice for Jayson. Subseries include: newspaper articles; ephemera, graphics, and flyers; and interviews. Series II is dedicated to materials about Bridgeport Generation Now. These include subseries of newspaper articles; website captures; website page samples; and interviews with organization members. Series III contains files related to the organization P.T. Partners, with subseries for interviews; newspaper articles; website captures; and website page samples.

**Provenance:**

The majority of the material in Series I was donated by the organization Justice for Jayson, coordinated by Mike Merli, the group's media specialist who created much of the content. Digital files in Series II and Series III were captured and collected by the History Center from online sources created by the Bridgeport Generation Now and P.T. Partners organizations respectively or local newspaper publications and sites. The History Center conducted interviews with members of Bridgeport Generation Now and P.T. Partners for this project.
