Abstract: The first Jewish man to serve on the Connecticut Supreme Court, Judge Samuel Mellitz was born in Bridgeport, Connecticut in May of 1891. His papers reflect legal analysis, notes, and

some historical research he undertook over his years of service as a judge.

Biographical History:

Samuel Mellitz was born on May 1891 in the City of Bridgeport to Jabob and Peppie (nee Hausman). He went on to study at Yale, and graduated in the class of 1911 with a bachelor of Law.

Judge Mellitz was active both as a judge and as a part of the Bridgeport Jewish community, although the latter is not reflected in these papers. (That material was donated to the Jewish Historical Society in 1983.) A member of the Jewish Community Council, Mellitz was active with various Jewish groups, including sitting on the Board of directors at Yeshiva University, acting as president of Bridgeport's Jewish Community Council, and president of Congregation Ahavat Achim in Fairfield, Connecticut.

He married Sadye L. Silverman in 1916, and had three children with her - Barbara, Jacob, and Beulah.

Mellitz's legal career began with a private practice, running from 1912-1935. Mellitz's first judicial appointment under Govenor Wilbur Cross came in 1936. From there, Mellitz served on the Court of Common Pleas and then the State Supreme Court of Errors - the highest court in Connecticut. He retained that position from 1958 until retiring in 1963 and was the first Jewish man to hold the position. Samuel Mellitz died in December 1982.
