**Abstract**: Reverend Roger Wentworth Floyd (October 8, 1930-August 2, 2013) was a Methodist minister who served in New Haven, Waterbury, and in the Greater Bridgeport area during his lifetime. He was active in the city's political scene as well, and ran for mayor twice against John C. Mandanici – in 1977 and 1979. He also served as the chairman of the Congress Plaza Planning Council Inc., which was the first urban renewal project in the city that was developed with

# **Biographical History:**

Reverend Roger Wentworth Floyd (October 8, 1930-August 2, 2013) was a Methodist minister who served in New Haven, Waterbury, and in the Greater Bridgeport area during his lifetime. Active in the communities where he served, his time in Bridgeport saw him become the executive directory of the Council of Churches of Greater Bridgeport, among many other roles. He was active in the city's political scene as well, and ran for mayor twice against John C. Mandanici – in 1977 and 1979.

Advocacy for the poor and addressing racial inequality was a part of Floyd's work. This shows in the collection through the inclusion of material from the Congress Plaza Planning Council Inc., the city's first cooperative city planning project with its residents. The group worked with the Bridgeport Redevelopment Agency to bring improved housing and infrastructure to the Congress Plaza area, eventually building the Unity Heights complex. The completed complex was turned into a coop, enabling those living there to be home owner. Floyd served as the group's chairman through the life of the project.

His wife, Joy, served as a reference librarian in the Bridgeport Public Library system for a time, and the couple had three children together.

# **Scope and Content note:**

These papers focus on Floyd's mayoral campaign and his involvement with redevelopment in Bridgeport. The mayoral campaign material features subject files on city issues, but also larger involvement within the national Democratic party, as Floyd was sent as an elector to the national

convention in 1980. Material related to Congress Plaza Planning Council Inc. makes up the bulk of the collection and provides thorough and complete documentation of the urban renewal project, the first in the city to focus on involving residents with all aspects of the work. These materials are key for understanding urban housing and redevelopment in light of white flight in the 1970s and 1980s, especially in Bridgeport as the city was hit particularly hard during those decades.

# **Arrangement Note:**

Material is arranged in three series: Campaign and personal files which are arranged alphabetically by subjects, issue files which are also arranged alphabetically by subjects, and Congress Plaza Planning Council. Inc. which has a brief set of subject files placed first, followed by the legal documents relating to land purchase and the final transfer of ownership to the coop, and then rounded out by the various binders of information relating to the ins and outs of the project. There are time period overlaps within the binder groups.
